#### A. Personal Statement

The goal of the proposed project is to expand cancer research, including increased accruals to clinical trials, particularly for minority and underserved populations throughout the Gulf South. As the senior executive at Mary Bird Perkins Cancer Center (MBPCC), I am responsible for the strategic development and implementation of all programs and services within an 18 parish service area that lessen the burden of cancer in the community (social services, awareness and education, research, and early detection), I have the experience necessary to help complete the goals of the project. I currently administer the early detection program which provides, at no cost, five different types of cancer screenings in an 18 parish service in southeast Louisiana through the use of medical mobile unit and in partnership with other local healthcare providers. Also, I am responsible for the delivery of cancer supportive services to patients undergoing treatment, including implementation of a comprehensive patient navigation program from screening through survivorship, quality of care components embedded in cancer care delivery models. I served as Principal Investigator on a three (3) year \$315,000 grant from the Ralph Lauren Cancer Center in Harlem, New York for patient navigation, one of only 5 grantees in the United States. I manage the delivery of patient and community education and awareness about cancer and cancer prevention as well as serve as an expert resource in the community as it relates to cancer incidence, mortality and prevention through our speaker's bureau and media appearances. I have overseen the successful development and implementation of both outpatient and inpatient tobacco cessation programs that have resulted in an average guit rate of 50%. I currently serve on the Leadership Teams of community hospital partners with whom we have cooperative endeavor agreements to ensure the delivery of comprehensive cancer care.
