A. Personal Statement

The Louisiana Health Sciences Center of New Orleans MBCCOP has a proven history of providing access to community–based cancer clinical trials to the underserved and minority populations within southeast Louisiana for 20 years. The goal of the proposed research is to improve cancer care among this population by allowing greater access to clinical trials. The development of a collaborative and integrated network such as the GS-NCORP, will serve as the framework to achieve this goal not only for the populations in Southeast Louisiana but, to expand the access to the entire State. Although new to the clinical trials industry, joining LSU in 2011, I have twenty-four years' experience as a professional registered nurse with the majority of my work history in systems design and management. Following my first five years as a critical care nurse, I moved into trauma systems management and administration where I successfully implemented new programs culminating in the development of the Medical Center of Louisiana, South Louisiana's first designated Level One Trauma Center.

In 2005, I joined the Louisiana Emergency Response Network (LERN), an agency of state government created by the Louisiana Legislature in 2004, charged with the responsibility of developing and maintaining a statewide system of care coordination for patients suddenly stricken by serious traumatic injury or time-sensitive illness (such as heart attack and stroke). As the Administrative Director, I was responsible for designing and implementing the local and regional care protocols used by EMS and hospital providers, communicated LERN's mission to the various stakeholders throughout the state, developed and implemented state and regional policies and procedures consistent with LERN's strategic goals, and designed the state wide registry used by hospitals and EMS agencies for trauma, STEMI & stroke care. As the Program Manager of the GS-MB-NCORP, my main objective will be to work with the PI and stakeholders to create an inclusive environment and infrastructure necessary to improve the care and access of clinical trials to the citizens of Louisiana.
