<ul> <li>Small for gestational age (SGA) is defined as a neonate with a birth weight less than 10<sup>th</sup> percentile for gestational age</li> </ul>	<ul> <li>1.Determine the prevalence of anemia in all patients delivering at our community hospital</li> <li>2.Understand the likelihood of SGA outcomes in anemic patients</li> <li>3.Determine if treatment of anemia during pregnancy improves the rate of appropriate neonatal birthweight</li> </ul>	<ul> <li>Overall, the average hemoglobin upon intake into prenatal care versus time of delivery was stable (11.8 vs 11.1 g/dL, respectively)</li> <li>Of the total population, 13.7% of patients (n=132) were anemic (measured at first prenatal visit) (Figure 2)</li> </ul>	

 SGA neonatal outcomes are associated with increased risks of stillbirth, preterm delivery, neonatal morbidity/mortality, and cognitive delay in childhood

- Maternal anemia is a preventable etiology of SGA
- SGA anemia is preventable with adequate prenatal care and identifying disparities in social determinants of health




Figure 1 – Breakdown of the study population. The flowchart shows the groups that were used to compare the various results. First, the anemic group was compared to the non-anemic group. The anemic group was further broken down based on whether patients were treated for anemia. The treated anemic, untreated anemic, and non-anemic groups were then compared.



- Anemic patients were more likely to have SGA neonatal outcomes compared to patients without anemia (15.5% versus 13.1%, respectively) (Figure 3A)




Figure 4 – Average birth weights. Comparing the

- Patients with untreated anemia were more likely to have SGA neonatal outcomes than patients with treated anemia and without anemia (15.8% vs 15.1% and 13.1%, respectively) (Figure 3B) Patients without anemia had the highest average birth weight (3101g) followed by patients with untreated anemia (3048g) and then patients with treated anemia (3021g) (Figure 4) • Patients with inadequate treatment of their anemia were more likely to be younger, have the same parity, and possess government issued insurance as compared to those with treated anemia [Age: 29yo vs. 31yo; Parity: 3.1 vs 3, Government

insurance: 92.2% vs 90.9%]

\* Treated anemia – initially anemic at the onset of pregnancy with improvement of Hgb to >10.5 g/dL by the time of delivery \* Untreated anemia – initially anemic at the onset of pregnancy without improvement of Hgb to >10.5 g/dL by the time of delivery

- A retrospective cohort study was initiated for deliveries at Touro Infirmary from 2018–2021 • Hemoglobin and hematocrit values
- were recorded upon intake into prenatal care and on admission for delivery
- Of the 1123 charts randomly selected from 2018-2021, 961 patients had hemoglobin (Hgb) levels available for both prenatal care in the first trimester and at the time of delivery
- Patients were classified as anemic if they had a hemoglobin of  $\leq 10.5$ g/dL
- SGA was defined by neonatal birth
