## **Curriculum Development/Implementation**

Serving as clinical instructor for medical students and residents on spine rotation with workup of spine patients from preoperative workup through postoperative care, evaluation of spine consultations, generation of differential diagnosis and treatment plan, and review of imaging modalities including radiographs, computed tomography scans and magnetic resonance imaging. Instruction also entails intraoperative teaching reviewing patient positioning, surgical approach, spinal decompression technique, placement of instrumentation and complication avoidance.

Responsible for development of the spine curriculum in the LSU orthopaedic surgery residency program including basic science and clinical spine applications, Orthopaedic In-Training Exam Review, Journal Club, in addition to cadaver lab covering surgical exposures and instrumentation and a monthly preoperative/postoperative indications conference.
