##### **February 2003-April 2004**

##### **Youth Leadership Program:**

Provided mental health services, social skills training, and mentoring to at-risk youth in Orleans Parish, New Orleans

##### **June 2004-May 2011**

##### **Louisiana Rural Trauma Services Center:**

Participated in program implementation in cooperation with the National Child Traumatic Stress Network, (NCTSN) and the Substance Abuse Mental Health Services Agency, (SAMHSA). Provided mental health assessment, treatment, crisis intervention, and educational services to children, adolescents, and their families exposed to traumatic events in West Feliciana, St. James and St. John

the Baptist parishes. Provided training to school personnel to enable them to identify and respond to traumatic events. Completed evaluations for St. James Parish Juvenile Court system to identify mental health difficulties that are contributing to youth recidivism. Provided services in St. Bernard, Plaquemines, and Orleans parishes to individuals impacted by Hurricanes Katrina, Rita, Gustav, and Ike as well as by the Deepwater Horizon Oil Spill. **March 2017-Present**

**Mother Infant Support Team (MIST)**

Implemented behavioral health support program to women in High Risk OB outpatient clinic at local hospital in New Orleans. Patients were screened for medical, psychosocial, and substance abuse issues. If desired, further supports were offered through in-person check-ins at OB appointments as well as through referrals for other services in the community. Patient was visited in hospital upon delivery of baby. A research component with nine monthly screenings was available. Beginning in February of 2020, an additional component was added in the NICU of local hospital. MIST support was offered to caregivers whose baby was in the NICU. In-person support was given while caregivers were visiting with follow-up phone check-ins.

**Autism Clinic without Walls Peer Mentor Training:**

Assisted Child and Adolescent Psychiatrist with facilitating training for parents of autistic children to become peer mentors for other parents of children with autism.

**May 2018-February 2019**
