Review from last month's call

Noteworthy current events/state updates from members of the Gulf Coast Coalition and/or NCTSN Mississippi:

Randy Foster, Director, Mississippi Office of Mental Health, Office of Incident Management: Provided update regarding Tornado/storm (EF2) damage in some areas of the state, specifically in Lauderdale county. MEMA (Mississippi Emergency Management Agency) was partially activated in response.

- WebEOC is a central hub for information and the way resources are requested. Lauderdale can put in a request for mental health services. It alerts relevant groups in the system. It is a good way of alerting and keeping record of needs. You can also keep a log of needed inventory.
- Group discussion about WebEOC. WebEOC does not go across state lines, E-MAC is able to cross state lines (Dee Harrison, Texas Health and Human Services Commission, Manager of Disaster Behavioral Health Services). MEMA would make the request for help to outside of the state for services (Michael Gilliam, Mississippi Dept. of Child Protection Services, Facility Operations Director).

Rick Costa (LSUHSC TDC4): Have kids been impacted related to MH?

Randy Foster: The difficulty for us is getting the information about specific kids being impacted and need services, but we are mindful of not overstepping. We often have to give reminders that we are here for mental health needs, make sure we are included. We have been working to get mental health into each of the response plans, to make sure that mental health is on the checklist with responders.

Michael Gilliam: Have you all developed a support mental health plan to go with the comprehensive emergency management plan? (Randy- it would be a great idea to come up with a step-by-step or guide) The schools may not be calling on mental health, but it would be better if it was an automatic part of the response/recovery effort).

Jackie Chatmon (Mississippi Department of Mental Health, Child and Youth Division Program Administrator):

- The Mississippi Trauma Informed Care Conference "From Knowledge to Skill Practice" will take place September 18-21, 2018 at the Jackson Convention Complex. This is the 5th trauma-informed care conference Over 500 participants every year attend the conference in Mississippi. We have a first responders track on the first day. - Update children and youth services- At one point we had a trauma-informed workgroup is to provide a blueprint for the state. We know people are doing things in silos, but they are not well-connected to other community and state-level groups. We are trying to get a list of these trauma-informed therapists so we can make a list of resources.

• E-mail update: "Regarding the event in Parkland, I know that the Managing Entity in that region was a part of dedicating staff from the providers to the schools. The state of Florida is working on a better collaborative between LE and the mental health providers as well as community leaders. At DCF, the secretary's office has tasked each local region with making sure that each county sheriff is aware of community meetings that they can be a part of in order to build better relationships, bridging any gaps between LEO's and providers."

Tonya Hansel, LSUHSC TDC4:

National resources that are available after critical incidents. 3. Activities/services that can be implemented in the longer term after a critical incident and make these efforts sustainable.

Tony Speier: Dee Harrison sent us the Texas plan as to how they are dealing with Harvey and FEMA's strategic plan. It builds on resilient communities.
